**TERMS OF REFERENCE** 

## 1. Introduction:

Resource Rights Africa is a research and advocacy organization formed in 2016 to advocate for the promotion and protection of people's rights in Uganda. The organization exists to champion social justice for all. We oppose discrimination, inequality, abuse of power and the unsustainable use of our natural resources including oil and gas, minerals, land, forests, water bodies as well as flora and fauna.

RRA is one of the most dynamic and robust regional leaders in cutting-edge public policy research and analysis in a range of areas including extractives, land, climate change, taxation and gender.

RRA's work is based on four (04) broad programme areas: **Natural Resource Governance**, **Climate Change and Livelihoods**, **Tax Justice**, **Agriculture Budget Monitoring and Advocacy**. Our core business is to undertake advocacy-driven public policy research and analysis on contemporary and emerging public policy and governance issues that have a significant impact on national development.

#### Vision

A just and peaceful world free from human rights violations.

### **Mission**

The mission of RRA is to advance social change for the protection and promotion of human rights where basic needs are met and resources are shared equitably; where people have control over their own lives and those in power act for the common good.

## **Values and Principles**

- iv. Requirements associated with the finance policy should be commensurate to the organizations' charitable status.

## 2. About the project:

In the Shadow of Mt. Moroto: Evidencing the Plight of Tepeth Minority Community in Karamoja's Mining Sector" is a project being implemented by Resource Rights Africa aimed at documenting the plight of the Tepeth community in the limestone value chain in Kosiroi, Tapac, Moroto District.

#### 3. The project Goal:

The project aim to document the injustices being experienced by the indigenous community members (the Tepeth) in the limestone value chain in Kosiroi, Tapac sub-county, Moroto District in order to influence policy change at national level on how mining companies undertake their operations and relate with indigenous communities.

## 4. Overall purpose of the consultancy:

The service provider will provide the following interrelated services:

- a) Capture and document most significant impacts of mining operations on the people resulting from limestone and gold mining activities in Moroto district;
- b) Capture the contributions of RRA in mobilizing communities to protect their right amidst mining operations;
- c) Capture high impactful pictures/phots depicting the life of mining communities in the limestone and gold value chains;
- d) The documentary will feature short videos from Artisanal and Small Scale Miners (ASMs), project staff, duty bearers, and representatives of mining companies in Karamoja subregion.

## 5. Terms and scope of the assignment:

This consultancy will focus on the following:

- a) The service provider is expected to capture people's voices from Moroto District to generate a pile of video footage that shall be used to generate at least 8 short videos on themes that shall be agreed upon with the Consultant and a 10-20 minute overall video documentary;
- b) The service provider shall be required besides the video documentary to capture high impactful photos/pictures depicting the plight of mining communities in Karamoja for a photo exhibition.

#### 6. Deliverables:

Eight (8) videos maximum specifically 2-3 minute short videos (segmented by themes) and one overall documentary video of not less 10min full length highlighting the work of RRA.

- a) A not less than 10 minutes DVD documentary on the Project featuring stories of change from beneficiaries and stakeholders on how the project has impacted on the beneficiaries;
- b) Selected 100 photos for exhibition;
- c) Soft copies of all the original raw footage from the recordings of the engagement; and
- d) Raw photos

#### 7. Duration and Timeframe:

The assignment period is one month not later than 10<sup>th</sup> December 2019.

## 8. Financial projection:

As a full consideration for the contract, RRA shall pay the service provider as per the schedule below:

- 30% upon signing of the contract
- 70% upon approval and submission of the final documentary, and photos
